## Information Regarding Non-GAAP Measures

This presentation contains references to "non-GAAP financial measures" as defined in SEC Regulation G, including Net Income – Adjusted, EBITDAC, EBITDAC Margin, Income Before Income Taxes – Adjusted, Income Before Income Taxes Margin – Adjusted, Diluted Net Income Per Share – Adjusted, and Organic Revenue. We present these measures because we believe such information is of interest to the investment community and because we believe it provides additional meaningful methods of evaluating certain aspects of the Company's operating performance from period to period on a basis that may not be otherwise apparent on a generally accepted accounting principles ("GAAP") basis. This non-GAAP financial information should be considered in addition to, not in lieu of, the Company's consolidated income statements and balance sheets as of the relevant date. Consistent with Regulation G, a description of such information is provided below and a reconciliation of such items to GAAP information can be found at the end of this presentation, as well as in our periodic filings with the SEC. Our method of calculating these non-GAAP financial measures may differ from the methods used by industry peers and, therefore, comparability may be limited.

**Revenue Measures** – We believe that Organic Revenue, as defined below, provides a meaningful representation of the Company's operating performance and improves the comparability of results between periods by eliminating the impact of certain items that have a high degree of variability. The Company has historically viewed Organic Revenue growth as an important indicator when assessing and evaluating the performance of its four segments.

Organic Revenue, a non-GAAP measure, is defined as commissions and fees less (i) the first twelve months of commission and fee revenues generated from acquisitions, less (ii) profit-sharing contingent commissions (revenues from insurance companies based upon the volume and the growth and/or profitability of the business placed with such companies during the prior year - "contingents"), less (iii) guaranteed supplemental commissions (commissions from insurance companies based solely upon the volume of the business placed with such companies during the current year - "GSCs"), and less (iv) divested business (net commissions and fees generated from offices and books of business sold by the Company) with the associated revenue removed from the corresponding period of the prior year. Organic Revenue can be expressed as a dollar amount or a percentage rate when describing Organic Revenue growth. We view Organic Revenue and Organic Revenue growth as important indicators when assessing and evaluating our performance on a consolidated basis and for each of our segments because it allows us to determine a comparable, but non-GAAP, measurement of revenue growth that is associated with the revenue sources that were a part of our business in both the current and prior year and that are expected to continue in the future.

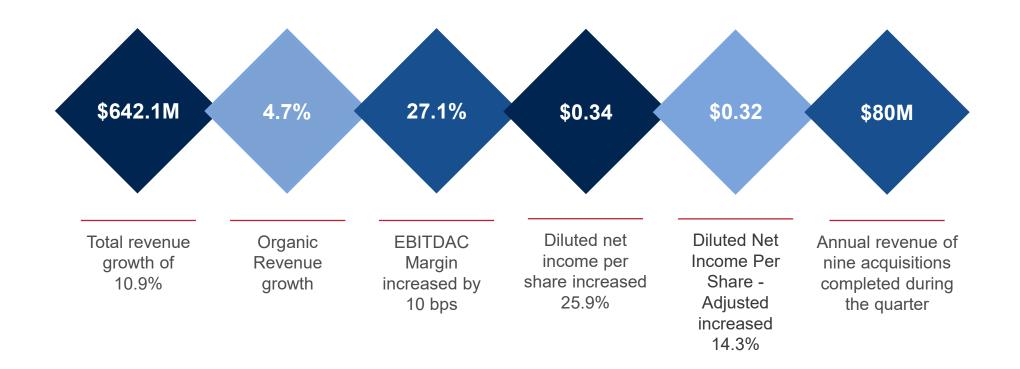
**Earnings Measures** – We believe these non-GAAP measures, as defined below, provide a meaningful representation of the operating performance of the Company and improve the comparability of results between periods by eliminating the impact of certain items that have a high degree of variability from period to period and that we believe are not indicative of the Company's ongoing performance.

- Net Income Adjusted is defined as net income, excluding the after-tax change in estimated acquisition earn-out payables.
- EBITDAC is defined as income before interest, income taxes, depreciation, amortization and the change in estimated acquisition earn-out payables.
- · EBITDAC Margin is defined as EBITDAC divided by total revenues.
- Income Before Income Taxes Adjusted is defined as income before income taxes, excluding the pre-tax change in estimated acquisition earn-out payables.
- Income Before Income Taxes Margin Adjusted is defined as Income Before Income Taxes Adjusted divided by total revenues.
- Diluted Net Income Per Share Adjusted is defined as diluted net income per share, excluding the change in estimated acquisition earn-out payables.

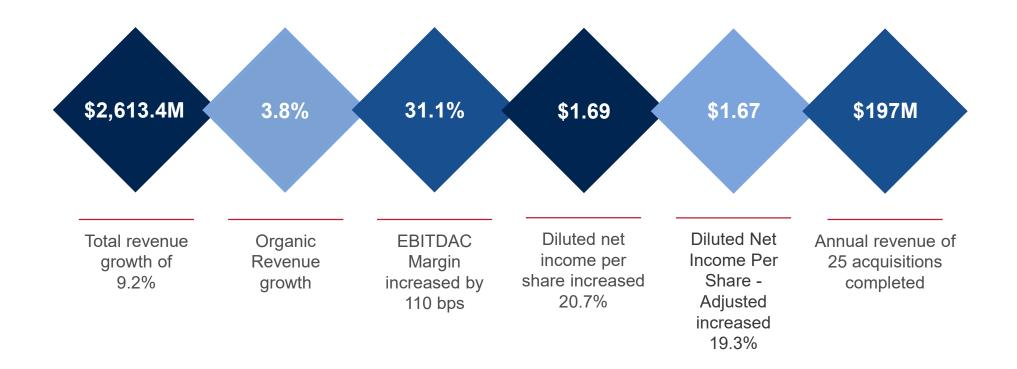

Premium rates for almost all lines continued to increase at similar levels as compared to the prior quarter

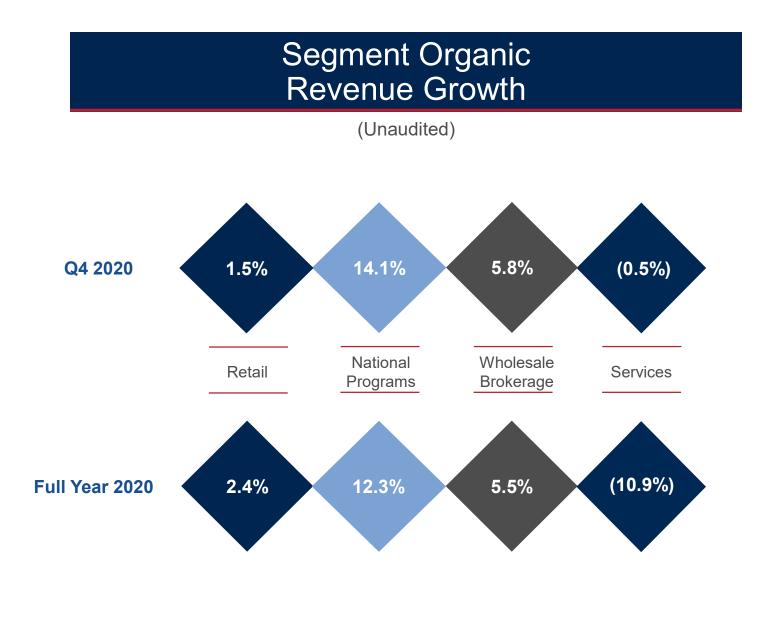


Carrier appetite or increased underwriting criteria continues to make placement of coverage for some customers difficult

#### **Business & Market Commentary**

Total revenue growth primarily driven by acquisition activity and Organic growth driven by improving new business, better customer retention and rate increases, partially offset by lower exposure units. Organic Growth negatively impacted by timing for revenues recognized in Q3 2020. Rate increases for most lines remained relatively constant at 3%-7%, with higher increases in commercial auto. Workers' compensation rates declined slower during the quarter. Income before income taxes grew faster than EBITDAC due to changes in estimated acquisition earn-out payables. EBITDAC grew slower than total revenue due to a lower gain on disposal of \$4.6 million as compared to Q4 2019, and higher non-cash stock-based compensation and intercompany IT charges, which were offset by leveraging total revenue and lower variable costs in response to COVID-19.

#### **Business & Market Commentary**

Total revenue growth driven by outstanding Organic Revenue growth and recent acquisitions. Organic Revenue growth remained strong for many programs, including lender placement, commercial and residential earthquake, wind and personal property. Income before income taxes increased faster than EBITDAC due to decreased estimated acquisition earn-out payables, which were partially offset by higher intercompany interest expense. EBITDAC growth was in line with total revenue growth due to leveraging Organic Revenue and lower variable costs in response to COVID-19, which were offset primarily by higher intercompany IT costs and decreased profit-sharing contingent commissions.

#### **Business & Market Commentary**

Total revenue growth driven primarily by acquisitions as well as solid Organic Revenue. New business and rate increases drove Organic Revenue growth, which offset continued headwinds within personal lines and binding authority. Coastal property rates remained up 15%-20% depending upon loss experience. Other property rates up 10%-20%. Professional lines rates generally up 10%-25%, with cyber rates up 10%-15%.

Income before income taxes grew slower than total revenue and EBITDAC, primarily due to higher intercompany interest expense. EBITDAC growth was driven by lower variable expenses in response to COVID-19 and leveraging higher Organic Revenue growth but was partially offset by increased expenses due to foreign exchange rates and higher intercompany IT charges.

### **Business & Market Commentary**

Total Revenue and OrganicIRevenue declined primarily dueto lower claims volume in ourSocial Security advocacyabusinesses, but wassubstantially offset by claimsprocessing revenue fromweather-related events.

Income before income taxes decreased due to a credit recorded for estimated acquisition earn-out payables in the prior year that did not occur in 2020. EBITDAC increased primarily due to lower variable expense in response to COVID-19 and increased weather-related claims, which were partially offset by higher intercompany IT charges.

M&A pipeline remains good

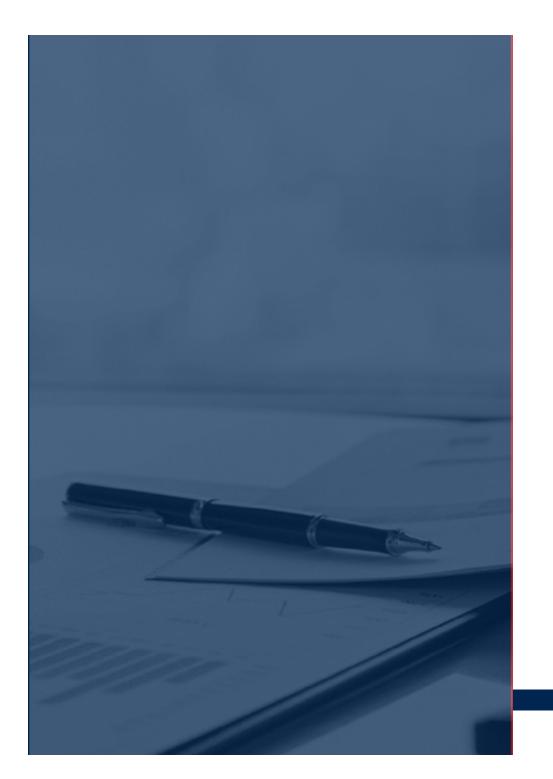
